

Making Sense of Certification

Almost everyone has heard that they should look for "board certification" when seeking a qualified plastic surgeon (or any other physician, for that matter). Most people don't really understand exactly what this means and what is involved in becoming "board certified."

Even fewer people know about certification of operating facilities, who certifies them, and what protection such certifications offer. We believe patients need this information to make informed choices in their search for the right surgeon, surgical facility, and anesthesia provider.

At our office, we have gone to great effort and expense to ensure the highest standard of safety for our patients. As you consider plastic surgery, we hope the following information will help you to evaluate the choices available to you.

CERTIFICATION OF YOUR SURGEON

The American Board of Medical Specialists (ABMS) is the agency that oversees sub-specialty boards. More than 100 "boards" have been submitted to the ABMS for formal approval, but only 24 have met their strict educational and examination criteria. They are as follows:

You may also call the ABMS at 1-800-776-2378 or visit them at their website: www.ABMS.org to see if your surgeon is certified by the American Board of Plastic Surgery. Give them the name of your surgeon, and they will tell you if and when he or she was certified. Certification by other boards does not give the same protection. Other boards have less strict criteria for certification, and some require only a fee. A few of the boards which have not been approved by the ABMS are as follows:

Making Sense of Certification (Cont.)

ANESTHESIA OPTIONS

Whenever you are heavily sedated or have general anesthesia, you put your life in someone else's hands. Much of that responsibility rests with the person administering the medications and monitoring your vital signs. You need to know the qualifications of the person assuming that responsibility. Their training can range from specialization after earning a medical degree (anesthesiologists) to specialization after nursing training (nurse anesthetists) to nurse training only.

We have chosen to use board-certified anesthesiologists for all of our general anesthesia and for monitored anesthesia care. Some of our anesthesiologists are board-certified in one other specialty as well. We have chosen physicians who are in active practice at a hospital because we believe their skills will be at the highest level in the event of an emergency.

OTHER ANESTHESIA PROVIDERS

Certified Registered Nurse Anesthetist (CRNA):

A CRNA is an RN who has completed an additional two years of specialized training in anesthesiology. Their certification is also overseen by each state's Board of Nursing. In contrast to an RN, a CRNA is able to administer general anesthesia.

Your Surgeon:

In some centers your surgeon may actually be the person administering the medications to make you drowsy during your surgery. Almost never does he or she personally monitor your vital signs. This is usually done by a member of his staff, most often a nurse.

Register Nurse (RN):

Each state has its own Board of Nursing, but there is a great deal of common requirements between states. He or she is licensed to administer intravenous drugs at the direction of the surgeon and monitor your vital signs.

Certified Plastic Surgical Nurse (CPSN):

These nurses have worked full time a minimum of two years in the field of plastic surgery before they are eligible to take a national certifying exam.

CERTIFICATION OF THE OPERATING FACILITY

At the present time, there are few local, state, or federal laws requiring office-based operating rooms to be certified. Any physician may perform any procedure in an office as long as basic fire and safety are met. No level of sanitation, patient care, monitoring, or peer review is required. Unfortunately, tragic consequences have occurred from faulty equipment, lack of trained personnel, and inadequate emergency equipment. As a result, there will most likely be requirements imposed in the future, but for now, certification is purely voluntary.

Medicare:

An Agency of the Federal Government with very strict requirements as to personnel, procedures and equipment. Our facility is Medicare certified.

American Association for the Accreditation of Ambulatory Plastic Surgery Facilities:

This Accreditation should be the minimum you seek when you choose a surgical facility.

Accreditation Association for Ambulatory Health Care:

An alternative national accrediting body that most insurance companies recognize.

The Personal Enhancement Centers Toms River office is conveniently located in central/coastal New Jersey. Our Toms River location is 1 hour from Philadelphia and New York City. We are discreetly located in the Orthopedic Medical Center and we are just minutes form the Garden State Parkway.

From the North:

Take the Garden State Parkway South to exit 89A. Turn right off of the ramp onto Route 70 East. Turn right at the first traffic light onto Shorrock Street (which turns into Beaverson Boulevard). When you reach Brick Boulevard/Route 540, take a right. Follow Brick Boulevard/Hooper Avenue approximately 4 miles. You will pass the Ocean County College on your right. Just after the traffic light you will turn right into the Orthopedic Medical Center. There is a large white water tower directly alongside the building. We are located on the second floor in Suite 200A.

From the South:

Take the Garden State Parkway North to exit 82/Route 37 East. Take the jug handle immediately after the second traffic light onto Route 549 North / Hooper Avenue. Stay on Hooper Avenue for approximately 3-4 miles. Stay in the right lane after Target / Lowes traffic light. Bare right into the jug handle, once you reach the stop sign take a left onto Indian Hill Road and cross over Hooper Avenue. Our building is on the right corner, next to the white water tower. We are located on the second floor in Suite 200A.

From Philadelphia:

Take the New Jersey Turnpike North to Exit 7A /Route 195 Shore Points. Take 195 to exit 35A for Route 34 South / Garden State Parkway South. The entrance for the Parkway South will be immediately on your right. Next follow the directions above from the north.

From New York City:

Take the New Jersey Turnpike South to the Garden State Parkway exit. The sign will say Shore Points. Next follow the directions from the North.

From the North:

Follow Garden State Parkway South. Use the right 2 lanes to take exit 98 for NJ-138/NJ-34 toward I-195/Belmar/Wall/ Trenton. Keep left at the fork and merge onto NJ-34 S. Destination will be on right, Allenwood Corporate Center. Our office is in Building A – Please use left side private entrance if you are a post-operative patient.

From the South:

Take the Garden State Parkway North. Take exit 98 toward NJ-138 W. Take exit 98 toward NJ-138 W. Keep right at the fork, follow signs for NJ-138 E and merge onto NJ-138 E. Turn right onto Allenwood Rd. Follow to NJ-34 S and take a left at the light. Destination will be on your right – 0.2 miles. Our office is in Building A – Please use left side private entrance if you are a post-operative patient.
